He requested the members to stand up and maintain two minutes silence in honour of the departed members.

He then requested Hon. Secretary, Economic Committee Sri.N.Surender to take-up the Agenda items for consideration. Secretary also welcomed the members and took up the agenda items as under.

1. To approve the minutes of the Annual General Body Meeting held on 31-03-2021. He said the minutes were already circulated. He said if there were any corrections to be made in the Minutes of the Meeting let us know. He

said he received a message from Sri. Veerender that by oversight we have missed one of his statements in the last AGM and he requested us to include the same in the AGM and the same will be entered in Page No.15 and para 3.

2. To approve the Minutes of Extra-ordinary General Body Meeting held on 18-04-2023. He said the President has mentioned that three members name were missing and the same would be included i.e., N.Surender, Aditya Margam and Hanumantha Rao for attending the meeting. An issue has come up whether everything a member speaks to be recorded. For example, if a person speaks for 20 minutes do we have to record verbatim. The President said we need to record only the relevant points and not every word spoken.

The President said generally 99% of the members are maintaining decorum in the meetings and we will try to achieve 100%. Please address the Chair for any point to be raised. He said if we miss anything please tell us so that we will again check-up the recording and then we will incorporate. Sri Papaiah Chakravarthy proposed approving the minutes of the General Body and Sri Hanumantha Rao seconded same.

- 3. To approve the report of the Economic Committee AP from 11-03-2021 i.e. in the last AGM to the 1st of June of 2023. The Chairman asked the members if they want the Secretary to read it completely as they have already been circulated in advance. The secretary report was approved as proposed by Sri Ashvin Margam and seconded by Sri Farooqui.
- 4. To approve the Audited Statement of Account for the years 2020-21, 2021-22 and 2022-23. The Chairman said the Auditors Report is from page number 38. Our new Auditors whom we have appointed i.e., M/s. Kumar & Giri and his team are here. If anybody has any clarifications to seek, they are welcome. The new Auditors have completely audited the accounts and because of the demise of Sri Venkat Rao the accounts were not complete, and the new Auditors helped in completing the accounts and they have also completed the entire Auditing. The accounts and the auditors report were approved as proposed by Sri Ashwin and Seconded by Sri Dilip Reddy.
- 5. Approve the Budget and Expenditure for the year 2023-24. Page No. 51. The budget was approved as proposed by Aditya Margam and Seconded by Sri Dhiraj Jaiswal. To a question why there has been no contribution from the Exhibition for the last two years, The chairman said due to covid pandemic no funds were allotted by the Exhibition.
- 6. Appoint the Auditors for the year 2023-24 and fix their remuneration.
  - The chairman said we have recently appointed M/s. Kumar & Giri and his team as Statutory Auditors, so let us continue with it. Of course, if anybody has got any reservations they can say. Whatever remuneration we are paying earlier, we will continue the same. The proposal was agreed.
- 7. Election to the Office Bearers. Chairman said the meeting is adjourned as we have to conduct elections, and we will resume the meeting after the elections. Members can have lunch and enjoy our hospitality and participate in Voting. Agenda is not completed and will continue. He said once you enter the Polling Area, please show your Identity Card like Aadhar, Pan or Driving Licence etc. either soft copy or hard copy. If nothing is available, we will come and identify the member so that he can vote. Nobody will go without voting, unless they come after 4:30 PM. Please do not go out. If anybody wants to do canvassing, they can do. We have also made separate entrance for elderly people above 70 years and also separate entrance for ladies. We will continue with the agenda items after elections. The election was held. Ballot Papers were read over. The following are the results: In the first bundle there were total 58 ballot papers out of which 48 ballots are valid and 2 are NOTA (Out of 386 Ballot Papers).

**Proposal to handover few of Exhibition Society Institutions to Economic Committee.** There was a proposal to handover the Management of Rajiv Gandhi ITI, Nirmal and Central Institute of Commerce, Tarnaka to the Economic Committee. There are certain advantages and disadvantages with this move. Harinath Reddy speaking on the proposal said that running of educational institutions doesn't fall in the scope of constitution of the EC and hence needs further review. It was decided to make a detailed study on this subject After discussions the item was

deferred for the present. The chairman said we will authorize the new incoming Managing Committee to discuss on this issue, and take a decision to come before the General Body for approval. Chairman invited Hon.Joint Secretary to propose a vote of thanks.

The President of Economic Committee Dr. Gangadhar Rao gave a talk on **Exciting field of Blockchain Technology & Crypto Currencies** to the computer science students at the Sri Venkateshwara Engineering College Suryapet last year.

That is why three members of Economic Committee are nominated to be on the managing committee of the Exhibition society. In this connection the Economic Committee MC Members undertook a study tour to visit the International Exhibition being held in the Global Village in Dubai on 21st to 25th February 2024.
